1. All requests for use of CCS Bard Archives materials, whether in publications, motion pictures, videos, or performances will be considered on a case-by-case basis.
2. It is the responsibility of the researcher to obtain any required copyright permissions from the copyright holder, which in some instances may be the CCS Bard Archives, before copies will be made. Copies of the permission letters must be submitted with this completed form.
3. It is the policy of the CCS Bard Archives to assess a Use Fee for the commercial use of materials from its collections. The CCS Bard Archives reserves the right to judge whether a proposed use is commercial based on the nature of a project and its intended audience. The CCS Bard Archives also reserves the right to assess fees for the use of its material in non-commercial projects, in particular when use is deemed to be significant or extensive. Such fees are negotiated on a case-by-case basis and are intended to offset a small part of the Archives' costs associated with processing, preserving, and public service of its manuscript collections.
4. Use fees cover non-exclusive, one-time use only unless otherwise indicated and are to be paid in advance. They are assessed in addition to any duplication costs.
