PRESENT CIVIL RIGHTS WEEK 2020 FAIR HOUSING FILM FESTIVAL August 24-28

Civil Rights Week is the Office of Equity and Civil Rights' Annual Celebration of Baltimore's storied Civil Rights past, the ongoing work of the present, and hopes for the future.

Due to COVID-19, this year's Civil Rights Week will be comprised of virtual events and socially distant film viewings.

The Fair Housing Film Festival will engage local youth to present creative projects exploring their connection to civil rights and fair housing in Baltimore. In addition, the agencies within the office will present a week of webinars, tele town halls and workshops exploring intersecting themes of fair housing, equity, policing, labor rights and disabilities access.

Who We Are

The Office of Equity and Civil Rights is a city agency devoted to advancing equity and upholding the federal and local civil rights laws, local living and prevailing wage laws, ensuring disabilities access, creating equity in City policy, procedures and service delivery, and providing oversight of local law enforcement. The mission of the Office of Equity and Civil Rights is to carry out activities to eliminate inequity, inequality and discrimination.


Why Housing?

Students of all ages from Baltimore City Schools are invited to submit 5-10 minute films under the following categories:

- Disability Rights in Housing
- Housing Equity
- Police and Housing
- Wage and Housing



Community Voices in Fair Housing

Equity and civil rights is about uplifting the voices of communities and telling real Baltimore stories. To help achieve this goal, we will be hosting a Fair Housing Social media contest.

Baltimoreans are invited to make Instagram, Twitter, Facebook, and TikTok posts about their own experiences with housing discrimination and the importance of fair housing for all.

At the end of the week, the post with the most engagements (likes and shares) on each platform will receive a prize.



Connecting Community to Resources

We're not alone in working to address these issues, or in providing critical services to the people of Baltimore.

That's why a portion of the Film Fest will be dedicated to a Virtual Resource Fair. Organizations that provide resources will submit 2-5 minutes films describing the services they offer. Any digital materials will also be included in folders with each video (brochures, flyers, etc.). Organizations will also be encouraged to submit their films in multiple languages.
