ACTIVITY RELEASE AND WAIVER

PLEASE READ CAREFULLY BEFORE SIGNING. THIS DOCUMENT INCLUDES A RELEASE OF LIABILITY AND WAIVER OF CERTAIN LEGAL RIGHTS.

I hereby acknowledge that I understand the health risks associated with participating in Junior League of Palo Alto-Mid Peninsula (JLPAMP) activities, namely potential exposure to coronavirus, a virus that causes serious illness (COVID-19) and may lead to death.

I understand that JLPAMP has implemented social distancing measures, increased hand washing, frequent cleaning of common surfaces and other hygienic practices as appropriate. I understand that, despite such precautions, the risks associated with transmission of COVID-19 remain high. I understand that the nature of many activities makes it difficult to observe all of the recommended precautions at all times; for example, individuals will not always be six feet apart, infrequent and incidental moments of closer proximity and contact are likely to occur, and surfaces may not always be free of viruses and other infectants, etc. As a result of participation in JLPAMP activities and proximity to other participants, I understand I may contract coronavirus, followed by serious illness and possibly death.

I understand and agree to abide by the measures and practices implemented by JLPAMP. I further understand that I may not participate in JLPAMP activities if I am sick or experiencing any COVID-19 symptoms as defined by the Centers for Disease Control (CDC). I also agree to notify JLPAMP if such symptoms appear within fourteen (14) days after participating in JLPAMP activities, and I consent to JLPAMP disclosing the existence of such symptoms to others as it deems necessary.

WAIVER, RELEASE, AND INDEMNIFICATION:

Knowing the risks of participating in JLPAMP activities, and the precautions taken by JLPAMP, and as a condition of JLPAMP allowing me to participate in such activities, I hereby knowingly and voluntarily (for myself, my heirs, executors, administrators and assigns) assume such risks and waive, release, indemnify, and hold harmless the JLPAMP, and/or any of its constituent organizations, agents, employees, contractors, and volunteers (collectively, "Released Parties") from all demands, claims, or liability arising from or in any way connected with JLPAMP activities or that involve any infection, sickness, or death to me. I HEREBY ACKNOWLEDGE AND EXPRESSLY AGREE THAT THIS WAIVER, RELEASE, AND INDEMNIFICATION APPLIES TO CLAIMS ARISING OUT OF THE RELEASED PARTIES' OWN NEGLIGENCE, but does not apply to claims of criminal conduct, gross negligence, or intentional acts.
