Payment Methods:

- Bacs payments should be made using the following details. IMPORTANT: If paying by bacs please ***make sure that there is an appropriate reference*** with your payment so that we can identify the payment. - Payment by Instalments: A payment plan is available to members wishing to pay by Standing order. Payment is £18 a month (to reflect the additional work for the Treasurer) and must be paid on the 1st of each month.

Summary of Membership Categories:

- ☐ A full member is entitled to vote at any General Meeting of Members. There is no lower age limit for full membership.
- ☐ Student membership is open to persons below the age of 26 years on the 1st October of the current membership year and in full time education.
- ☐ Junior membership is open to children under the age of 19 years on the 1st October of the current membership year.
- ☐ Family membership is available to immediate family members only.
- ☐ Day Time membership is available for persons not wishing to use the courts during peak time late afternoon and evening sessions. Daytime membership allows court usage in the evenings at weekends but not in the evenings on a Bank Holiday.
- ☐ Out of County membership is open to anyone who resides outside of Cornwall.
- ☐ Social Membership is open to anyone who has attained the age of 18 years. A social member may use the facilities of the Club with the exception of the courts.
- ☐ Corporate/Group Membership is available for joint applications of a minimum of 4 new members at the same time, the terms for each member are equal to that of a full member. Each member should complete their own application form which should then be submitted along with those of the other group members and the full payment for the group as a whole. There is no limit to the maximum number of applications that form one group.
- ☐ No refunds will be given for membership fees in the event that the membership is no longer required or due to injury, relocation or other change in circumstances, except by decision of the Committee.
